












### Modules Service / Product - Concept










# Modules Service / Product – Implementation/Deployment



### **User Representative**



- Important role making decisions for the partner <u>User</u> at the <u>Execution</u> level
- Is in fact a <u>Product Owner</u> and no longer a simple specialist
- Can decide to change the scope of the project without a Change Request or decision by the Sponsor
- Replaces the <u>Business Process Owner</u> and the <u>Application Owner</u>
- Is appointed by the Sponsor, but does not sign the Execution Order



# Sponsor and Project Manager



- Are responsible for the success, resp. for the management of the project
- Commit themselves by signing the Project Execution Order
- How can the Sponsor assume its responsibility without releasing the Execution?
- How can the project manager ensure the management if the user representative decides on priorities, changes, etc.?



#### **Development Team**



- The development team organizes itself
- It can have a lead, a representative, or not
- What is the role of a sub-project manager when there are development teams?



# Planning DTI and TÜV SÜD



- Strict transition on April 1, 2023
  - No more HERMES 5.1 manuals
  - No more HERMES 5 certifications
  - Reference manuals in German, French, Italian (?), English (?)
- Upgrade of the certifications
  - Upgrade certification (!)
  - Coverage of all modules for HERMES Advanced (?)
  - In the short term, only available in German and French
  - Calls for tender will require the new certifications

# Vademecum, eLearning and blended learning




- Vademecum, eLearning and blended learning planned for 1 February 2023
